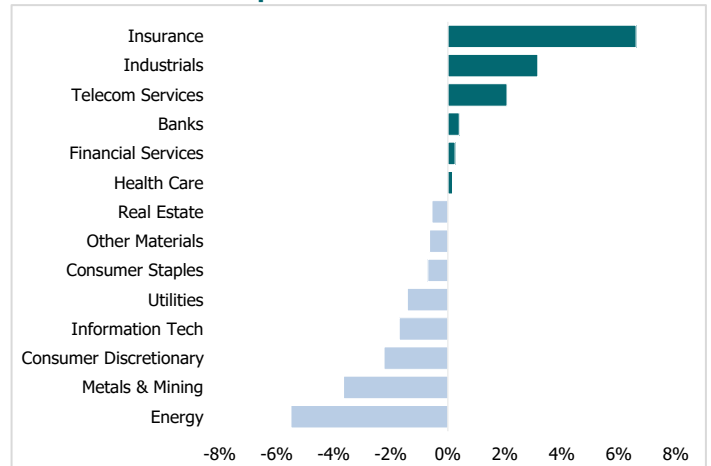

### Active Sector Exposure



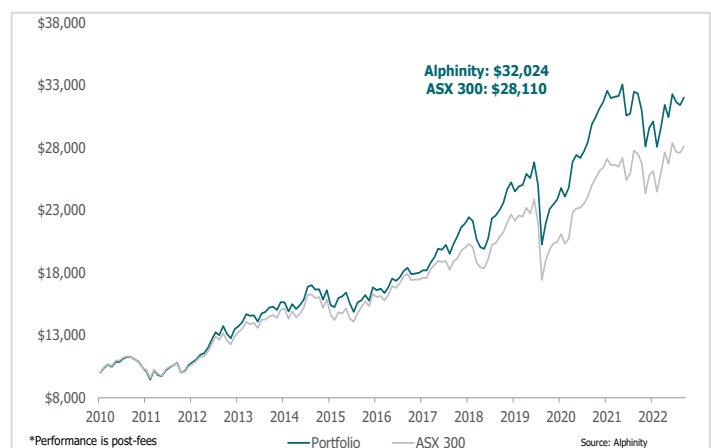
